DIRECT PAYMENT SERVICE FOR YOUR WATER & SEWER AND PROPERTY TAX BILLS

The City of Center Line is offering you the opportunity to pay your water & sewer and/or property tax bills through our Direct Payment Service. By sending in a completed Direct Payment Enrollment Form, your water sewer and/or property tax bills will automatically be deducted from your specified checking account on the bill due date.

Using the Direct Payment Enrollment Form, you can choose to have either one or both your water & sewer or property tax bills paid each billing period from your checking account.

Please continue to pay your water and sewer and/or property tax bills as you would normally until you have received notice from the City of Center Line that your direct payment enrollment form has been approved by the City of Center Line for this service.

The Direct Payment Service is provided to you at no charge. Most financial institutions do not charge for this service; **however you should consult with your financial institution to determine if it does not charge for this service**.

Once you have signed up and been notified of your enrollment, you will still receive bills for the selected services identified on your Direct Payment Enrollment Form. Should you decide to cancel the Direct Payment Service, you may stop by the City of Center Line City Hall, or write to the City of Center Line, Attention: Direct Payment Service, 7070 E. 10 Mile Rd., Center Line, MI 48015. Should you need another Direct Payment Enrollment Form, you may stop by the City of Center Line City Hall, or print a copy of the Direct Payment Enrollment Form at www.centerline.gov.
