**1. PLUMBING PERMIT FEE SCHEDULE**

- a. All permits shall be assessed a non-refundable application fee of \$75.00
- b. The Permit Fees for any plumbing permit shall be \$70.00 per inspection. One inspection and the administration fee are required on all permits. Permit renewals shall be \$30.00. Permit fees are non-refundable after work has started and non-transferable.
- c. Contractor registration fee shall be \$1.00 for plumbing (all categories).
- d. Permits for new construction shall be for the minimum number of inspections required in Section 2.

- e. All investigative fees equal to the permit fee, shall be assessed if a permit was not issued prior to commencement of work.
- f. A fee of \$50.00 per inspection shall be charged for the re-inspection of all failed inspections.

**2. INSPECTIONS: MINIMUM NUMBER AND WHEN REQUIRED**

- a. Plumbing: Single-Family Residential

For new construction an underground, rough, and final inspection shall be required.

Remodels shall require a minimum of two inspections, a rough and a final. For all other types or work of this class, inspections shall be required for each visit required from the plumbing inspector.

- b. Plumbing: Multiple-Family, Commercial, Industrial

Each unit in a multi-family structure or in a multi-tenant structure shall require a rough and a final inspection. A multi-family structure or other multi-tenant building shall require an additional inspection for underground plumbing at the rate of one inspection per building. An additional inspection shall be required for sewer and water services.

For all commercial and industrial buildings shall be charged at the rate of one inspection for each visit required from the plumbing inspector. The inspector shall estimate the number of visits required.

A separate inspection shall be required for temporary service.
