

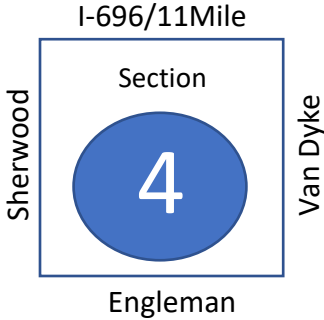

**CITY OF CENTER LINE CLEAN-UP YOUR NEIGHBORHOOD  
WHAT CITY INSPECTORS & PUBLIC SAFETY OFFICERS WILL ISSUE TICKETS FOR  
RESIDENTIAL BLIGHT/PROPERTY MAINTENANCE**

**Unregistered or inoperable vehicles  
will be ticketed and towed!**

- ✓ The owners will have 48 hours to move the vehicle or the VEHICLE WILL BE TOWED AT THE OWNER'S EXPENSE.
- ✓ Illegal storage of recreational vehicles, including utility trailers will be ticketed.
- ✓ Recreational vehicles and boats cannot be parked in front or side yards, rear yards only on an approved surface.
- ✓ An inoperable vehicle is any vehicle that is not equipped with all parts that are required to legally operate it on public streets and/or under its own power.

- ✓ Accumulation of waste, debris, rubbish, garbage, trash, and animal feces.
- ✓ Storage of metals, wood, vehicle parts, tires, household items, etc.
- ✓ Businesses operating out of a residence; storage of business equipment, materials & supplies.
- ✓ Illegal signs, fences, sheds, storage units, carports & pools.
- ✓ Evidence of rodent presence on properties, food sources, etc.
- ✓ Houses, garages, sheds, or other structures in need of repair/paint; to include, but not limited to; shingles, siding, soffits, windows & doors.
- ✓ Vacant buildings or structures that are neighborhood eyesores.
- ✓ Unkept/unfiltered pools. Pools must be kept clean at all times



**City of Center Line Enforces 6" Grass/Weed Height Ordinance**

City ordinance limits grass height to 6 inches, including along the fence line. This ordinance refers to all weeds, grass, wild brush, and vegetation. **This includes front, sides and back yards. The City will cut grass over 6" at owner's expense.**

**City of Center Line Curbside Refuse Pickup Rules & Trash Cart Management Program**

- ✓ Residents are required to use Trash Carts provided by the City. Additional Trash Carts can be ordered from GFL Environmental at property owner's expense.
- ✓ Recycle Materials Carts (65 and 95-gallon units) can be ordered from GFL Environmental at property owner's expense. **Call 844-464-3597.**
- ✓ Larger household items can be placed at the curb next to Trash Carts.
- ✓ All trash must be placed in a trash bag, prior to placing in Trash Carts.
- ✓ Trash Carts must be stored behind the home or garage, or inside the garage. Front or side yard storage is not allowed
- ✓ Household trash shall not be placed at the curb outside of the Trash Cart unless the unit is filled. Homes where weekly trash regularly exceeds capacity of Trash Cart should consider purchasing a second unit.
- ✓ Larger household items, such as furniture, appliances, etc. should be placed at the curb, and property owner/occupant should contact GFL Environmental to notify them of those items.



## STREET SWEEPING

City of Center Line Department of Public Works will continuously be sweeping the streets. If possible, please move your vehicles off the street so that the street sweepers can do their job effectively and efficiently. **Generally, Street Sweeping will occur several times during the Spring, Summer and Fall seasons (No Set Schedule).**



## HERE IS HOW YOU CAN HELP KEEP CENTER LINE BEAUTIFUL

The City of Center Line Ordinance Officers and Public Safety Officers will conduct a clean sweep of your neighborhood. Please place all discarded items at the curb including appliances, furniture, carpeting, wood or large items you no longer want and they will be picked up on your regular trash pickup day. **You must ensure that trash containers lids are always closed.**

**DID YOU KNOW:** All homes must have addresses with 4-inch numbers (dark numbers against a light color background attached to the front of the home.

## RECREATIONAL VEHICLES, EQUIPMENT AND TRAILERS

Recreational vehicles (RVs), RV equipment and trailers can be stored in an interior side yard providing such storage does not cause a nuisance to adjacent properties; is kept in good repair; and properly licensed with the Secretary of State. RVs, RV equipment and trailers can only be stored in a rear yard in accordance with the Zoning Code, Sec. 801 (which covers height and set-backs). All stored RVs, RV equipment and trailers must be stored on an approved surface; and should not be stored or parked in the driveway between homes (this is a fire hazard).

### VACANT BUILDINGS/STRUCTURES

Vacant structures are the responsibility of the property owner. Property owners must maintain their buildings, structures and grounds so as to not cause a blight problem. Residents should report vacant buildings/structures to the Building Department at 586-757-6800.
