Liability Waiver**

In consideration of being allowed to participate in any fitness class, event, or activity offered by the City of Center Line Parks and Recreation Department, and in consideration of being permitted to use any facilities in connection therewith, I \_\_\_\_\_ (please print full name clearly), the undersigned, acknowledge and agree that:

1. I fully understand that fitness classes and other activities require physical exertion, which may be strenuous and may cause physical injury, including but not limited to serious bodily injury, permanent disability, or death. I am fully aware of the risks and hazards involved with my participation and freely and voluntarily assume all risks, both known and unknown, even if arising from the negligence or alleged negligence of the Releasees named below.

2. I fully understand that the instructor may have no medical training and is not qualified to diagnose or treat any medical condition or to assess my ability to participate in any particular activity. I agree that I am solely responsible for monitoring my individual exercise program and activities. I agree to comply with all stated and customary terms and conditions for participants.

3. I acknowledge and agree that it is my responsibility to consult with a physician prior to and regarding my participation. I represent that I am qualified and in good health and proper physical condition to participate in any class or activity in which I choose to participate.

4. I acknowledge and understand that the City of Center Line is immune from liability to the extent provided by Michigan law.

5. I hereby knowingly and voluntarily, unconditionally and absolutely, waive, release, and discharge any and all past, present, and future claims, liabilities, costs, expenses, demands, and causes of action against the City of Line, its departments, employees, officers, representatives, and agents ("Releasees") that are in any way related to my participation in a fitness class, event, or activity offered by the City of Center Line Parks and Recreation Department. I intend this waiver, to the maximum extent permitted by law, to be effective even if my injuries are caused by a negligent act or omission of Releasees.

6. I agree to indemnify, defend, and hold harmless Releasees from all liability, claims, demands, causes of action, costs, expenses, and attorney fees (including attorney fees to establish the Releasees' right to indemnification or incurred on appeal) resulting from or related to my involvement in the fitness classes, events, or activities, or in the use of any facility in connection with the fitness classes, events, or activities.

**I HAVE READ THIS LIABILITY WAIVER, FULLY UNDERSTAND ITS TERMS, AND HAVE SIGNED IT FREELY AND VOLUNTARILY AND WITHOUT ANY INDUCEMENT.**
